- 1. Announcements and Introductions: Guests were introduced as listed above.
- 2. Approval of October 9, 2018 Board Minutes: MR. BARLOW MOVED THAT THE OCTOBER 9, 2018 BOARD MINUTES BE APPROVED. MR. MONGER SECONDED THE MOTION AND THE MOTION CARRIED.
- 3. <u>Presentation on Licensure The What, Why & How:</u> Ms. Kathy Nelson, Compliance Supervisor, provided a review of licensing and other regulatory requirements.
- 4. **HRCSB Board Quarterly Report:** Ms. Albrite reviewed the Quarterly Board of Directors' Report, a requirement of the Department of Behavioral Health and Developmental Services (DBHDS) Community Services Performance contract, as previously e-mailed to Board members.



5. Closed Session: §2.2-3711(A)(1) – Personnel Matter: MS. ADDITIONALLY, THAT SHERYL FALLS, HUMAN RESOURCES MANAGER, BE PERMITTED TO CONSULT DIRECTLY AS REQUESTED BY THE PERSONNEL COMMITTEE. MS. BUDD SECONDED THE MOTION AND THE MOTION CARRIED.

- 10. Other Business: Board members present unanimously agreed to cancel the December Board meeting.
